INTRODUCTION

- In India, we do not have adequate and appropriate toilets in public areas, especially for female/transgenders.
- This results in the public, utilising any area, open field, and other such places. It's not only unhygienic but also does not give basic privacy for those people.
- Wherever available, most of the Public Toilets are unclean, dark, unventilated, not maintained, not functional, in short, basically unusable.

THE CHALLENGE

- This PUBLIC TOILETS Architectural Design Competition aims to
- provide a Public Toilet that is not only usable but such that the next person doesn't have to think twice before using it.
- The design should not only be by itself functional, but also be able to be installed or located in the available space, plus enable portability, i.e., can be lifted and moved to another location, without too much of modifications.
- And either in one unit or as a module.
- The built-up area would also include some spaces for Waiting, for interacting with others, to make it maintained, and cleaned, on a regular and frequent basis, so that the area remains hygienic.
- The WC toilet cubicle will be a minimum 1200 mm X 1500 mm, to accommodate either the Indian styles or Western styles.
- Urinals will have design detailing to keep the floor clean.
- The liquid and solid waste should be collected, and treated locally, and not to be discharged in the common sewerage line, except grey water, if necessary.
- The system will be given as a concept in this phase, and details can be completed at a later stage

SITE/LOCATION

- Site dimension is of 20 m X 15 m
- As it is an open design, there is no specific location, as per the brief.

DRAWING REQUIREMENTS

- Conceptual Floor Plans, including Roof/Terrace Floor Plan
- Sections
- Elevations, View/s, Details.
- The scales should be a minimum of 1: 100 for general drawings, and 1: 10 or larger for details.
- All drawings have to be self-explanatory in graphics or text.


• The organiser of the PUBLIC TOILETS FOR THE PUBLIC Competition is The Ar. Achiever

Eligibility

- This is a Design PUBLIC TOILETS Competition to allow design solutions to be used practically and to enable the construction of public toilets all over India.
- It is open to Students of recognised colleges of Architecture.
- For this PUBLIC TOILETS Competition, Single-person entries only.

REQUIREMENTS

- Three copies of each A2-sized drawing in landscape format of Plans, Elevations, Sections or any other detail to explain the design concept along with a softcopy in PDF format
- The entries should be presented with a level of detail appropriate to the
- character as a design concept presentation.
- All entries are to only be in English.
- Entrants should ensure anonymity by not mentioning their names or any identification in any of the submission documents, to obviate the rejection of the entry.
- All the drawings, and documents are required to have the registration code.
- Submission can be done in PDF only along with concept drawings.
- Total file size shall not exceed 20 MB.
- The solution to the larger concerns of existing community/ public toilets.
- Technical Specifications of the Components of the Toilets along with construction.
- The entries should be drawings, illustrations and 3D views with only explanatory notes, as required. Soft copy, in PPT or PDG format.
- Entries submitted by the entrants for the purpose of this PUBLIC TOI-LETS FOR THE PUBLIC TOILETS FOR THE PUBLIC Competition will not be returned.



DETAILS


- To explain and support your design, use easy-to-understand Text, Video, and Audio, apart from the drawings.
- Materials specified should be such that walls and floors can be kept easy to clean.
- And detailing such that the floor is kept as dry as possible.
- All surfaces are to be kept dry, and a fresh ventilation system is to enable fresh air in, and bad smell out.
- Indoor and outdoor plants are to be used for fragrance and vision.
- All areas are to be universally accessible, and heights for all activities for
- different age groups/genders.
- Apart from jet spray, toilet paper, soap, paper napkins, diapers, and sanitary napkins, are available and disposable facilities.
- Private family room for children.
- Alternate energy supply like solar electricity.
- Suggested ways to manage the toilets by Human resources monitored by Information Technology.

ASSESSMENT

- The Jury will have Architects and Professionals with full credibility.
- The discretion of the Jury will be final.
- Though entrants will be able to view the Jury assessment online, they will not and do not have the right to comment on the same, nor the records on the adjudication process and the Jury decisions are final and binding on completion of the procedure of evaluation, the award date, time and place will be announced and distribution of prizes to the winners as declared by the Jury.
